REACH EU Regulation

Dear Business Partners,

Thank you for your inquiry about REACH. REACH is the regulation concerning registration, evaluation, approval and restriction of chemical substances. The regulation, which came into effect on June 1, 2007, and improve the previously applying legal framework conditions for chemical substances in the European Union (EU).

HEMA Maschinen- und Apparateschutz GmbH is, as a manufacturer of a product (article) in the sense of REACH a "downstream user". The products, which you obtain from us, are products and therefore do not liable for registration under REACH. As a downstream user within the meaning of REACH, HEMA Maschinen- und Apparateschutz GmbH is generally not subject to any registration obligation.

In our own interest and to ensure high product safety we comply with strict quality regulations in accordance with ISO 9001:2015 and RoHS 3. We closely monitor the implementation of REACH and the resulting requirements.


In particular, we are in constant contact with our suppliers, from whom we obtain chemical substances and preparations that we use in our production process (e.g. auxiliary materials such as lubricants, adhesives, paints, varnishes, etc.). Our processes are essentially widespread applications that are carried out in high tonnages in many industries. Against this background, many of our suppliers have already signaled to us that the relevant substances will be pre-registered or later registered.
